ORDINANCE NUMBER 2023-06

ORDINANCE LEVYING AND ASSESSING TAX FOR THE CARLOCK PUBLIC LIBRARY DISTRICT

IN THE COUNTIES OF McLEAN AND WOODFORD IN THE STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING THE $1^{\rm ST}$ DAY OF JULY, 2023 AND ENDING THE $30^{\rm TH}$ DAY OF JUNE, 2024.

WHEREAS, the President and Board of Trustees of the CARLOCK PUBLIC LIBRARY

DISTRICT, in the Counties of McLean and Woodford, in the State of Illinois, passed the Annual

Budget and Appropriation Ordinance for the fiscal year commencing on July 1, 2023 and ending on

June 30, 2023 (Ordinance Number 23-05) on August 29, 2023; and

WHEREAS, the Annual Budget and Appropriation Ordinance was published, as required by law, after its passage; and

WHEREAS, the Carlock Public Library District met the requirements of Illinois's Truth in Taxation Act, by properly publishing notice of the Truth in Taxation Hearing, and subsequently holding the Truth in Taxation Hearing prior to vote on this Levy Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE CARLOCK PUBLIC LIBRARY DISTRICT in the Counties of McLean and Woodford, in the State of Illinois, as follows:

Section I: That the total sum of TWO HUNDRED TWENTY-FOUR THOUSAND ONE HUNDRED DOLLARS (\$224,100) composed as follows: The sum of ONE HUNDRED SEVENTY-SIX THOUSAND THREE HUNDRED DOLLARS (\$176,300), required for the necessary corporate purposes of the CARLOCK PUBLIC LIBRARY DISTRICT; the sum of TWENTY-THREE THOUSAND FIVE HUNDRED DOLLARS (\$23,500), required for building maintenance purposes; the sum of TEN THOUSAND DOLLARS (\$10,000), required for the employer's portion of Social Security and Medicare contributions for its employees; and the sum of FOURTEEN THOUSAND THREE HUNDRED DOLLARS (\$14,300) necessary for the purpose of payments of premiums to

purchase liability insurance, property damage (fire) insurance, and for risk management, loss control, and legal fees for defending or otherwise protecting itself against liability; be levied and assessed upon all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2023 and ending June 30, 2024.

The Board of Trustees of the CARLOCK PUBLIC LIBRARY DISTRICT passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning on July 1, 2023, and ending July 30, 2024, at its Board Meeting on August 29, 2023. The Budget and Appropriations Ordinance was only passed after a properly noticed public hearing was held and the Board concluded that the specific purposes and amounts listed in the Annual Budget and Appropriations Ordinance are required and necessary for the operation of the CARLOCK PUBLIC LIBRARY DISTRICT, and therefore, the amounts listed do need to be levied. The Annual Budget and Appropriations Ordinance was published, after its passage and adoption, in a newspaper of general circulation within the Library District, as required by law.

Section 2: The Secretary of the Board of Trustees of the CARLOCK PUBLIC LIBRARY

DISTRICT is directed to file a certified copy of this Ordinance with the County Clerks in McLean

and Woodford Counties in Illinois, in accordance with the laws of the State of Illinois, on or before
the last Tuesday of December 2023. The County Clerks are authorized and directed to extend the
taxes levied by this Ordinance, according to law, against all taxable property within the CARLOCK

PUBLIC LIBRARY DISTRICT. The Secretary of the CARLOCK PUBLIC LIBRARY DISTRICT

shall also file, on or before the last Tuesday of December 2023, certified copies of the Annual

Budget and Appropriation Ordinance and this Ordinance with the CARLOCK PUBLIC LIBRARY

DISTRICT where they shall be available for public inspection.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
